## February 2024 Legislative Report

#### **Texas Won't Surrender Shelby Park**

After a long wait, U.S. Customs and Border Protection has finally reported that the number of illegal alien encounters at the border for December 2023 broke the all-time record. Encounters with illegal aliens totaled 302,034—the highest ever recorded in a month. Border Patrol also arrested 19 individuals in December who are on the FBI's terrorist watch list. Meanwhile, Attorney General Ken Paxton is refusing to surrender Eagle Pass' Shelby Park to the federal government. The park has been a popular and convenient entry point for illegal aliens. The Biden administration's policy has been to meet the aliens there and then release the aliens into the country. The state took over the park on January 11 and has refused to allow federal agents in so that the illegals could be deterred—through barriers and blockades—or arrested for criminal trespass. The flow at the park has gone from thousands to a dozen. Now the Biden administration is demanding the state allow agents to enter the park so they can remove Texas' barriers. Paxton sent a letter to the U.S. Department of Homeland Security with his own demands—including that they provide an “explanation of where the Congress has empowered your federal agency to pursue this scheme” “As I said before, this office will continue to defend Texas’s efforts to protect its southern border against every effort by the Biden Administration to undermine the State’s constitutional right of self-defense,” stated Paxton in a letter.

Appeals Court Sides with Taxpayers on Debt-Hiking Constitutional Amendment Justices on the 7th District Court of Appeals ruled that a constitutional amendment put before Texans in 2021 by the legislature was not honest with the voters. Brandon Waltens wrote the story. At issue was Proposition 2, which passed with 63 percent of the vote. It authorized counties to issue bonds—taxpayer-backed debt—to fund infrastructure and transportation projects in underdeveloped, unproductive, or blighted areas and to use increases in property taxes from those areas to pay off the debt. The problem? The ballot mentioned nothing about new taxes and as such, a lawsuit was filed by grassroots organizations, and the program was put on hold. An identical proposal had previously failed at the ballot box when it included information about debt and taxes. In 2021, lawmakers simply removed that language. "Hidden from view was the ultimate responsibility for payment and its positioning over the voter's head like the sword of Damocles," explained the courts.

## **“The Texas Voice”**

George Soros, the liberal New York billionaire and prolific political donor who has long sought to transform the criminal justice system, made significant investments into progressive political organizations in Texas last year. According to campaign finance reports filed with the Texas Ethics Commission, Soros donated over \$2.5 million to a handful of Democratic Party organizations and leftist political action committees across Texas during 2023. The Texas Voice previously reported on some of these donations, including \$100,000 to the Cameron County Democratic Party and \$250,000 to the Texas Organizing Project PAC. In addition to the donations to those two organizations, Soros’ Texas donations during 2023 included: \$200,000 to the Dallas County Democratic Party \$50,000 to Planned Parenthood Texas Votes \$62,000 to the Texas Justice & Public Safety PAC \$1,400,000 to Texas Majority PAC \$300,000 to CTX Votes \$100,000 to First Tuesday \$100,000 to the Hidalgo County Democratic Party The Texas Tribune reported earlier this month that the Texas Majority PAC was recently formed by former staff members of Beto O’Rourke and the Texas Organizing Project in an effort to flip Texas to the Democratic Party. Texas Majority PAC reported spending over \$900,000 during the second half of 2023, largely on hiring staff and building organizational infrastructure ahead of the 2024 election.

### **Texas House Members Did Not Vote to Raise Their Pensions**

In the ongoing Texas Republican civil war, groups seeking to unseat Texas House members who voted for Paxton’s impeachment, have been sending mailers and running ads alleging that the House members voted to raise their pensions in the last session. The allegation is, at best, a gross misrepresentation. Ironically, the subject of the ads is a bill that never passed. Early in the session, a bi-partisan bill ([HB438](#)) was introduced which would have indexed judges’ salaries to the Consumer Price Index. As the bill moved through the House, an issue was raised about whether this indexing would raise legislators’ pensions because retired Texas legislators receive a pension that is based on what a district judge is paid. The argument by some was, therefore, that by raising judicial salaries, the legislators were indirectly voting to raise their own pensions.

When the issue was raised, the sponsors of the bill requested an opinion from the Texas Employee Retirement System, as to whether the bill would affect legislative retirements and were told that because the provisions were in different sections, the indexing would not affect their pensions. This is a clip from the House debate on HB438, in which Rep. Mike Schofield assured the members they are not voting to increase their pensions. By the way, Schofield is a Republican conservative stalwart who worked for Rick Perry for over a decade before being elected to the House.
